## CHECKLIST INSTRUCTIONS OF ADVANCED NURSE AIDE CERTIFICATION

**Enclosed Fee:**

Fee is payable by check or money order to: Treasurer of Virginia

Pursuant to Virginia nursing regulation <u>18 VAC 90-25-110</u>, in order to be certified as and use the title of "Advanced Certified Nurse Aide," an applicant shall meet the following qualifications:

(1) Hold a current Virginia nurse aide certificate, (2) Have been certified for at least three years as a Virginia certified nurse aide, (3) Have never had a finding of abuse, neglect or misappropriation of patient property entered on a nurse aide registry in any jurisdiction and have not had any disciplinary actions taken by the board within the five years preceding application for advanced certification, (4) Have a recommendation for advanced certification from a licensed nurse who has supervised the applicant in providing direct patient care for at least six months within the past year; and (5) Have successfully completed a minimum of 120 hours of advanced training in an approved program that includes a competency evaluation acceptable to the board.

<u>Note</u>: Applications and fees are only retained for one (1) year only. If not, all requirements are met within 1 year of the Board receiving the application and fee, a new application and fee will be required.

	<u>Completed Application and required Fee (\$25)</u> : Fees must be paid by check or money order, made payable to The Treasurer of Virginia. An application will not be reviewed or considered until payment is submitted. Fees are non-refundable.
	Current Virginia nurse aide certificate, certified in Virginia for at least 3 years
	<u>Virginia Licensed Nurse Recommendation:</u> Have a recommendation for advanced certification from a licensed nurse who has supervised the applicant in providing direct patient care for at least six months within the past year
	<u>Verification of 120 hours of Advanced Training:</u> Have successfully completed a minimum of 120 hours of advanced training in an approved program that includes a competency evaluation acceptable to the board.

	I have enclosed from the clerk(s) of court, certified copies of <u>all</u> criminal conviction records OR if court records have been destroyed, a criminal history report from the Virginia State Police; and/or orders or actions from other state(s).
